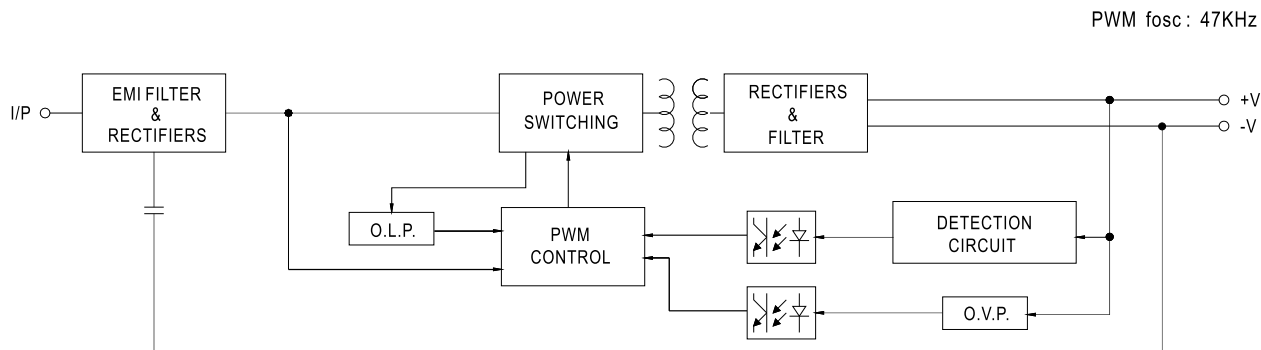

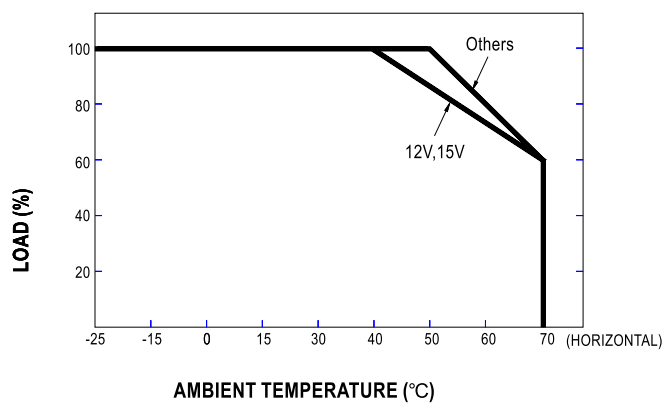
■ Recommend Mounting Direction



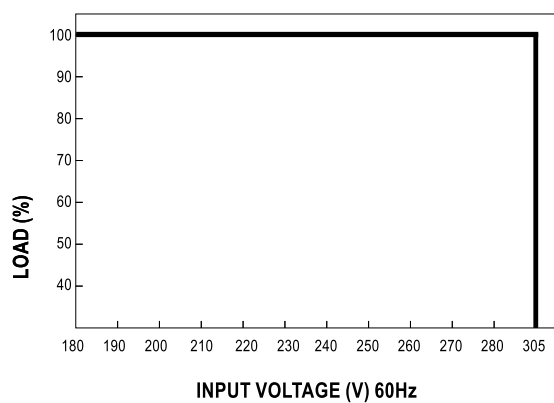
■ Block Diagram


